

POSSIBLE PUNISHMENTS*

- Cancellation of admission.
- Suspension from attending classes.
- Withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any tests and examinations.
- Debarring from representing the institution in any regional, national and international meet, tournament, youth festival, etc.
- Suspension / expulsion from the hostel.
- Rustication from the institution from period ranging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution.
- Collective punishment as a deterrent to ensure community pressure on the potential raggers
